

EBV Project



Last year saw a very successful start to the BAS EBV project with 30 herds contributing data from 5,000 alpacas. The data collection will carry on this season. If you would like to join in with this development project then you can. Any member can join anytime.

What you need to do is weigh your shorn fleece and get a mid-side-sample analysed. Art of Fibre are project p[partners and offer preferential rates for participants in the project.

The value of EBVs comes from their use in breeding plans because they help breeders achieve the aims of their breeding plan more quickly and more accurately than might otherwise be achieved for the traits that have EBVs.

The benefits of an EBV system are that the breeding progress is:

- Permanent the benefits stay with the alpaca for life
- Cumulative improvements made in one generation are added to those made in previous generations, and
- Sustainable improvements can continue to be made for hundreds of generations

EBVs will help breeders make better breeding decisions, identify good and bad alpacas early, and can help with the valuation when buying and selling.



Placements for Veterinary Students at Bristol University

The need for vets with camelid knowledge has been increasing rapidly in the last few years and a good way to encourage more students to take an interest in Alpacas is to offer 1-2 weeks of pre-clinical Extra Mural Studies (EMS) EMS placements for veterinary students. Whilst we do receive some training in camelids at university, EMS is a great way to show students what is involved in camelids, their husbandry and how your businesses work- and hopefully give them the alpaca bug!

What is Pre-Clinical EMS (or AHEMS)

As part of all UK veterinary degrees, students must undertake 12 weeks of animal husbandry/ preclinical extra mural studies (EMS) during the early years of their degree. This gives students an opportunity to learn hands on husbandry, different management protocols and an understanding of common problems and diseases. Covid has had a huge impact on availability of placements, with many students struggling to find ones for this summer, so please do consider offering if you are able to.

What do you need to host students?

In order to host students you will need:

- Personal Liability Insurance
- Employer liability Insurance
- Some patience and time to show them what to do!

If you can offer accommodation this could really help some students who do not live locally/cannot drive, however it is not a requirement and plenty of students probably

live within a commutable distance.

Working farms of all sizes and focuses (breeders, fleece producers, trekking) are welcome to take students. Students are expected to work the same time per week as a full-time worker.

Consultation on future governance of the vet professions

Animal owners urged to complete consultation on future governance of the vet professions. The Royal College of Veterinary Surgeons (RCVS), the regulator of UK veterinary surgeons and veterinary nurses, is urging British pet owners to take part in a consultation on proposals for future laws that will govern the nation's veterinary professionals and practices.

The RCVS Legislation Reform Consultation runs until **Friday 23 April 2021**, and asks for views and feedback on a series of recommendations on how the law could be changed to allow for better and more efficient regulation of the vet-led team, more flexible and compassionate concerns investigation and disciplinary procedures, and the enhanced regulation of veterinary practices.

Although members of the public are welcome to respond to any aspect of the consultation, recommendations that may be of particular interest to animal owners are:

- Protection in law for veterinary titles including 'veterinary nurse', so that only those who are appropriately trained and registered as veterinary nurses may use the title.
- Expanding the scope of the RCVS to regulate not just veterinary surgeons and veterinary nurses, but other allied professionals within the vet-led team, for example, veterinary technicians.
- Having mandatory practice regulation because, at present, the College can only regulate individual veterinary surgeons and veterinary nurses, rather than veterinary practices. This would mean the RCVS has greater scope to ensure standards are being met
- Widening the grounds for investigating complaints made about veterinary surgeons or veterinary nurses so that the RCVS can intervene in cases where a practitioner might pose a risk to animals, the public or the public interest for reasons other than serious professional misconduct.

- Allowing the RCVS to temporarily suspend a a veterinary surgeon's or veterinary nurse's ability to practise pending the outcome of an investigation or disciplinary hearing where they may pose a significant risk to the public or to animals.
- Introducing a wider range of sanctions for those who appear before a
 Disciplinary Committee including conditional or restricted practice orders.
- Changing the standard of proof used to determine the facts of a complaint from the criminal standard ('beyond all reasonable doubt') to the civil standard ('on the balance of probabilities') in line with other healthcare regulators.

Dr Mandisa Greene MRCVS, President of the Royal College of Veterinary Surgeons, commented: "The views of the animal-owning public are vital for this consultation because the ultimate role of the RCVS as a regulator is to improve the health and welfare of the nation's animals, as well as public confidence in the veterinary professions, through the standards that we set.

"As we are looking at recommendations for major changes that will, in our view, improve how we set and uphold these standards, animal-owner feedback is a crucial component, and will impact how we decide to move forward with this set of proposals.

"Please also remember, you do not need to complete the entire consultation but can choose to comment on those recommendations which are most important and relevant to you."

Once the consultation has finished the results will be analysed and, in due course, a series of formal recommendations for changes to the law will be made to the Department for Environment, Food & Rural Affairs

Breeding Alpacas

The birthing season is nearly with us and after that the breeding season. Planning for the breeding season is important because it can make the rest of the year so much easier

There are some things to know that are helpful to avoid future problems

- Average gestation is 345 days but can vary from 330 to 370 days
- Most people target late spring/early summer for births for decent weather and grass growth., so to hit a May/ June birth the breeding is going to take place in June/ July
- Births "out of season" may require extra feeding or shelter to avoid problems of exposure.
- Young females are ready to be put to a stud male only when they have reached 60 per cent of the weight of their mother. With good nutrition this is possible as yearlings but more likely they will be approaching their second birthday. If mated at 60% of mature weight then continued good nutrition is important so the female can grow herself and support the development of the cria.
- Following a normal birthing and complete cleansing within 12 hours of birth, a female should be in a fit condition to return to a male from 10-14 days post partum.
- It is known that some males are able to breed from about nine months of age but most males are not ready for use until they are 2-3 years old.
- Alpacas are induced ovulators, which means the female releases her egg in response to the act of mating.
- Alpaca mate in the cush position so a female that is not ready will not sit down and may spit at the male.
- During copulation, the stud male intrudes through the cervix of the female
 and deposits sperm repeatedly into each uterine horn. This action can cause
 damage to the uterine lining and disrupt a developing pregnancy so frequent
 and indiscriminate mating should be avoided. Hence keeping a male with a

- group of females is not good practice it is much better to manage the matings by introducing the male or the mating and then removing him afterwards. This also helps with getting the correct pedigree recorded!
- After the initial mating a "spit off" should be conducted to confirm pregnancy
- You can get your vet to confirm pregnancy with ultrasound but you should wait at least 6 weeks before using this method (because the foetus may be too small to see otherwise)
- The selection of stud males is an important decision. The stud should be chosen to make improvements to the traits that you are interested in.
